

# Terms and conditions of IMEKOFOODS 2020 conference

## 1 Applicability

The 5<sup>th</sup> International Conference of The Technical Committee 23 of IMEKO (IMEKO TC23) – IMEKOFOODS 2020 is organised by the Czech University of Life Sciences Prague, Terpenix s.r.o. and The Technical Committee 23 of IMEKO. ## 2 Agreement

Once you have registered for the meeting, you will receive confirmation about your registration by email.

## 3 Cancellation

Only written cancellations can be accepted, to be sent to [info@imekofoods.cz](mailto:info@imekofoods.cz).

Cancellation of participation in the conference: Cancellation before September 1, 2020 – refund 75%; no refunds after that date. Where an individual fails to attend and has not cancelled in advance, the full conference costs are also payable. It is acceptable to send a substitute to the meeting.

## 4 Changes to the program, location of the conference

Where there is good reason to do so, the organizer is entitled to change the location of the conference. Attendees will then be permitted to withdraw. Where there is good reason to do so, the conference may be cancelled; any charges that have already been paid will be refunded. No claims for compensation above and beyond this will be valid. Irrespective of this, the organizer may cancel the meeting up to 14 days before it starts without giving a reason. In case of force majeure, neither party may hold the other liable for any delay to or non-performance of the agreement which results from this force

majeure. The organizer reserves the right to make changes to the program at any time.
